

Terms & conditions:

- Emoluments:** @Rs. 42,000/- (Rs. Forty two thousand only) per month (consolidated) as per rules.
 - Engagement period:** The post is purely temporary on a contractual basis for duration mentioned above from the date of joining of the Young Professional-II (YP-II) under the project. The engagement as YP-II shall stand automatically terminated with the project. However, the engagement can be extended in case the project duration is extended by the funding agency subject to satisfactory performance of the candidate as per rules.

The candidates should bring the filled-in application form (as per the format annexed), all the original certificates from matriculation onwards, date of birth certificate, degree certificate either original or provisional and one set of the self-attested photocopies of all the required certificates from matriculation onwards and an attested copy of recent passport size photograph pasted onto the application form. Proof of experience and publications also need to be submitted.
5. The post is purely temporary and can be terminated any time without assigning any reason/ on the basis of performance. The positions are for a maximum period of one years. Further, the positions are co-terminus with the project and either due to expiry of project or non-availability of funds anytime (Purely temporary).
